## PUBLIC NOTICE

### TENDER 2 – RIGHTS OF WAY

**TENDERS** are invited for the **TRASHING, CUTTING** and subsequent **CLEARING and REMOVAL** (all waste to be disposed of appropriately) of the under mentioned Rights of Way:-

**(1) LLANSAIN**

- (a) COCKLEWAY (BOAT 62/36) - From its entrance at Gwernmont (formerly Heol-yr-Eglwys) to where it meets Bryn-y-Mor Road including the grassed centre.**
- (b) BRIDLEWAY 62/48 – (Heol Rist, Llansaint on the Llansaint/Kidwelly road to Portway road).**

The Cockleway and Bridleway to be maintained in a condition to allow a horse and rider to pass unhindered throughout the period April – September 2020.

**(2) FERRYSIDE**

- (a) FOOTPATH 62/19 – (Brigstocke Terrace to the former Robert’s Rest, Ferryside) (Behind the White Lion Hotel)**
- (b) FOOTPATH 62/25 – (Undercliff, Ferryside to Beach)**

The Rights of Way to be maintained in a condition to allow pedestrians to walk unhindered (hedges cut back and grass mowed), weeding paths and ensure they are free from litter throughout the period, April – September 2020.

**The Tenders must be returned to the undersigned no later than 5.00 p.m. Friday 28th of February 2020, in a sealed envelope clearly marked “TENDER”. Any envelope not so endorsed will not be considered.**

All work must follow Carmarthenshire County Council guidelines regarding Managing Road Verges for Safety and Biodiversity

The Council does not bind itself to accept the lowest or any tender and payment will not be made until works have been completed, inspected and approved.

Tender price quoted should be net of VAT and the VAT status of the person submitting the Tender must be made known to the Council with the VAT number provided where appropriate.

Tenderers are invited to propose a stage payment plan if required.

A copy of a current Public Liability Policy must be submitted with the Tender

A copy of a current Waste Carriers Licence must be submitted with the Tender.

**PAYMENT MAY BE AFFECTED IF THE FOLLOWING CONDITIONS ARE NOT MET:**

- Contractor must notify the Clerk after every cut, site inspections will be carried out the last week of each month and reported back to the Clerk.
- Any substandard works notified to the contractor following inspection must be rectified at the earliest opportunity.
